Why is the personal data being collected?

This list of National Focal Points is published on UNESCO's website in order to encourage and facilitate bilateral and multilateral cooperation.

How will we use your personal data?

The data are publicly disclosed on UNESCO's website and are therefore freely accessible to all third parties. UNESCO may also share this list with other States Parties to the 1954 Hague Convention.

How long do we keep your personal data?

The list will be updated regularly, upon submission or update of contact details, and at least every four years following the submission of national periodic reports. Personal data may be deleted upon written request by either the concerned State Party or the individual concerned.
